CODE OF CONDUCT FOR PARENTS 2022/2023

Our players' well-being, safety and enjoyment of playing football is one of the essential aspects of AFC Fradley, and we need everyone to help to support them in playing the game we all love.

We have created a parent and spectator code of conduct to help outline the behaviours we expect (parents can be much harder to manage than the children!):

- Please remember that children play for fun and enjoyment.
- This is not a professional sport, so please have fun watching them play.
- 😥 Do not shout or criticise any player during the game.
- I understand and agree if I am coaching or shouting instructions to my child or any others from the touchline, my child will be immediately taken off the field of play until I leave the coaching, giving instructions to the coach.
- I can shout encouragement and positive support but can not coach or give instructions unless I am an official coach. I will know I am an official coach because I will wear a coach's tracksuit and be part of the coaching team.
- I understand if I want to be able to give instructions and coach from the touchline, AFC Fradley will welcome me with open arms to join the coaching team (subject to an interview and safeguarding checks).
- Respect the Referee's decisions even when you disagree with them.
- Encourage the players to respect the opposition, referee and match officials.
- Appreciate good play from both teams.

Spectators' Area. If any area is not defined, please remain a sensible distance from the pitch

- Remain behind the touchline along the side of the pitch and within the Designated Zone.
- Please remain a sensible distance from the pitch if any area is not defined.
- Never engage in offensive, insulting or abusive language or behaviour.

If our supporters do not follow our code of conduct, we may need to take action; you will be:

I understand that if I do not follow the Code, I may be:

- · Issued with a verbal warning or asked to leave
- Required to meet with the club committee, league or CFA Welfare Officer
- · Obliged to undertake an FA education course
- Requested not to attend future games, be suspended or have my membership removed
- Required to leave the club along with any dependents and/or issued a fine

PLAYERS CODE OF CONDUCT

We want our players to play for fun and enjoyment but also play fairly and within the spirit of the game. Below are some rules from the FA's Respect program we would like them to remember:

When playing football for AFC Fradley I will:

- Always play to the best of my ability and for the benefit of my team.
- Respect my team-mates, the other team, the referee, and my coach/manager.
- Never engage in bullying, offensive or abusive language, or any behaviour which may deliberately hurt a team mate or other player.
- Play by the rules, as directed by the referee.
- Listen and respond to what my coach/team manager tells me.

I understand that if I do not follow the code I may be:

- Required to apologise to my team-mates, the other team, the referee or team manager.
- Issued with a warning from the coach or the club committee.
- Substituted or asked to miss a match.
- Suspended from training.
- Required to leave the club.

In Addition:

- The FA could impose a fine and suspension against me.
- Players are responsible for any fines raised against them (including for a yellow card).

AFC FRADLEY SOCIAL MEDIAL GUIDANCE

Purpose

With social media a prominent method of communication for the club and a key way we engage with our members, along with the wider community, it is important for us to have a policy to demonstrate how we ensure we are represented in a suitable way and can take action should the need arise. We are taking this opportunity to remind our players and supporters of the importance of ensuring that all our social networking streams should be used thoughtfully and responsibly.

While the Club positively encourages social networking among members, we are mindful of the need to ensure that all content is suitable for publication and does not breach any laws or common decency. It is not acceptable to post or communicate with members items that may include reference to a person's ethnic origin, colour, race, nationality, faith, gender, sexual orientation or disability, and any member found to have posted such items will be subject to disciplinary action. In addition, any abuse of match officials, opposition etc may be deemed by the FA to bring the game into disrepute and lead to disciplinary sanctions against both the author and/or the Club. Participants should be aware that comments which bring the game into disrepute, or are threatening, abusive, indecent or insulting, may lead to disciplinary action.

Cyber Bullying

All reports of cyber-bullying and other technology misuses will be investigated fully and may result in notification to the police where AFC Fradley is obliged to do so. Sanctions may include, but are not limited to, suspension, or banning from membership of AFC Fradley. Members must be aware that in certain circumstances where a crime has been committed, they may be subject to a criminal investigation by the police over which the club will have no control.

Mobile and Online Communication with Children

Technology is moving very fast in this area. There are now many different ways for people to communicate. The risks posed by such methods of communication arise from:

- The privacy. It is often one-to-one.
- The wide range of content that can be transmitted, including content of a violent, sexual or hateful nature.
- The ease with which images can be forwarded onto others.
- The difficulty in knowing truly who you are communicating with. Where grooming happens, it often involves this type of communication.

In sport, there are additional risks:

- Inappropriate pressure can be exerted by adults, particularly coaches, on children (such as to play when injured).
- There can be inappropriate criticism of a young player's performance.

An official position or role within a club, such as Coach, can carry with it a level of authority and engender a level of trust that facilitates the control of a child.

Against this background, AFC Fradley will abide by all FA guidance with regard to mobile and online communication with children and vulnerable adults and will cascade any information for them to the parents (or carer) of that child or vulnerable adult. AFC Fradley will not directly contact a child or vulnerable adult directly by mobile phone or other medium unless prior consent is given by the parent or carer.

Club Communication Guidelines

All Age Group communications – for example fixture information, team availability – should be sent via a group medium, for example a WhatsApp group chat. Emails should only be sent using email groups comprising email addresses given by parents. An email should not be sent to a child unless the parent is also copied in.

Participants of such groups are determined by coaches of individual teams, and they will retain administrative rights over the group. As such, it is the coaches' responsibility to report any inappropriate use of the group and make decisions over what is appropriate or inappropriate content. Coaches should approach the committee if they require any advice or guidance on appropriate content. Equally, members of such groups should approach the coach with any concerns in the first instance, or if not possible or appropriate for them to do so, then they can approach the committee with concerns at any time.

SMS Messaging (Texting): Club Officials and Coaches should only communicate directly with individual children by text at any time, on any matter, if the parent or carer is copied on such communication or there is an immediate risk to the welfare of that child which can be lessened by such contact.

Sanctions

Any club member failing foul of this policy could face disciplinary action from the Club, which could lead to expulsion from the Club.
